5K Fun Run/Walk will begin at the intersection of Division and Wood Streets. Race day registration, race number and t-shirt pick-up from 7:00 to 7:45am. Race will commence at 8:00am. In order to participate you must be registered and numbered. Once all participants are present, we will proceed as follows:

A START at Division & Wood St.

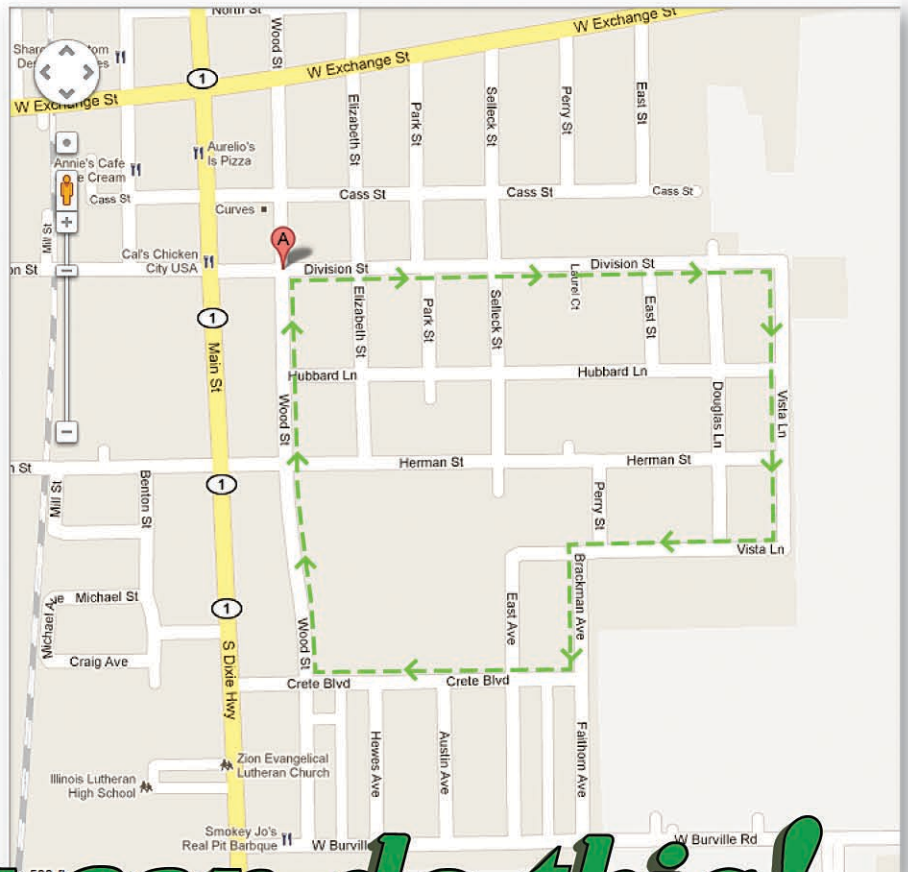
- go East on Division to end
- go South (right) on Vista Lane
- continuing right/West on Vista
- go South (first left) on Brackman/Faithorn
- go West (first right) on Crete Blvd.
- go North (right) on wood Street

A Halfway point, Wood & Division

- repeat from **START**

A FINISH on Wood Street at Division

- **Runners & Walkers** may finish after only one lap.
- Only 5K participants (2 laps) will be eligible for awards.
